PLEASE NOTE: In keeping with League policy, the candidates' answers in the Voters' Guide appear as submitted. Thus, some misspellings and typing errors may appear. If answers exceeded the specified character limitation, the additional words were cut from the end of the candidate's statement.

The Voters' Guide includes only the names of the candidates on the official ballot certified by state and local officials. Some candidates may have withdrawn since the material was compiled, and not every candidate listed in the the Guide will appear on every ballot.

PARTY PRIMARIES IN MARYLAND

Party primaries in Maryland are "closed" primaries. You must be a member of a political party to participate in that party's primary, though all voters may vote for nonpartisan offices such as the Board of Education. You may change your party affiliation up until the close of voter registration on May 27, 2020 by completing a voter registration form and submitting it to your Board of Elections. You may also change your party affiliation online if you have a Maryland driver's license or identification card from the Motor Vehicle Administration. If you have not previously registered to vote, you may until May 27, 2020, for the Presidential Primary Election. If using Maryland's Online Voter Registration System (OLVR), you have until 9:00pm to submit your application; or you may go to a vote center on election day in the county where you live.

In Maryland, only the Republican and Democrat candidates appear on official ballots published by the Board of Elections.

Primary Election in Maryland June 2, 2020

What You Need to Know to Vote!

On April 10, 2020, Governor Hogan approved an emergency plan for the June 2, 2020 Maryland primary on the recommendation of the State Board of Elections. The plan sets out procedures for the mailing of ballots as well as the operation of a limited number of facilities for in-person voting on June 2.

Campaigning will be severely restricted by the need for social distancing – Information on candidates for offices in every county in Maryland is being provided by the League of Women Voters at www.lwvmd.org/2020_voters_guides, VOTE411.org and local League websites. LWVMD will also continue to post updates to election processes online at www.lwvmd.org/covid_19_and_the_upcoming_elections

Voting by Mail - How It Will Work

Most voters will cast their ballots by mail for the Presidential Primary scheduled for June 2, 2020. Ballots will be mailed to voters on the active voter registration list, and a prepaid postage envelope for returning the ballot will be included in the packet mailed to each voter.

How to Complete & Return Your Mail-In Ballot

Ballots will be mailed with instructions for marking and returning them to the Board of Elections. Follow the instructions carefully – you must sign an oath that accompanies the ballot. Failure to complete the return envelope correctly may result in your ballot not being counted.

Ballots must be postmarked no later than 8:00 pm June 2 in order to be counted, but voters are encouraged to return them earlier if possible. The Board of Elections website includes a form where you can check to see if your ballot was received.

In addition to returning ballots by mail, voters may also choose to return their ballots using secure drop boxes. These drop boxes may be located at sites used for Early Voting in previous elections. (Note: Drop boxes will NOT be located at the local Board of Elections offices.) Each county will have between one and four of these drop boxes. Website and contact information for each county's local Board of Elections is available on the State Board of Elections website.

Protect your ballot -- Do not give your ballot to anyone who offers to collect ballots. Put it directly in the U.S. Mail or a Board of Elections drop box.

Voting by Mail & Party Affiliation

Voters will receive a Republican or Democratic ballot if they are affiliated with one of those parties. If there are nonpartisan races on the ballot (such as Board of Education or municipal offices), voters not affiliated with the Republican or Democratic parties will receive a nonpartisan ballot. Limited In-Person Voting

Voters who need to use a ballot marking device, those registering to vote for the first time, and those who did not receive their ballot but believe they are registered, will be able to vote in person on Election Day, June 2, from 7 am to 8 pm at voting centers that will be set up in each county. There will be at least one voting center in each county, but no more than four. These may be locations that were used for Early Voting in previous elections. Website and contact information for each county's local Board of Elections is available on the State Board of Elections website.

Because of the risk of transmitting the Covid-19 virus wherever large numbers of people are gathered, voters are strongly encouraged to vote by mail if at all possible and to use in-person voting only if it is not possible to vote by mail.

How Will These Changes Affect You?

Different groups of voters will be affected differently by these changes. Visit the topics below for information relating to specific groups of voters.

Have You Moved Recently or Missed an Election? Learn How You Can Ensure You Receive a Ballot

Ballots will be mailed only to active voters, using the address on file with the Board of Elections. If a mailing from the Board of Elections was returned because you had moved or were temporarily at another address and you have missed voting in the past 4 years, you may have been placed on the inactive voter list. You will not be sent a ballot unless you notify the Board of Elections of your current address. You must make any changes to your registration by the close of registration on May 27.

- You can verify your voter registration on the State Board of Elections website.
 Use the same website to update your address if it is not correct.
- 3. If you are temporarily staying at another location and would like your ballot sent there, you should request an absentee ballot you can do this on the State Board of Elections website.
- 4. If you do not receive your ballot when other voters do, you should apply for an absentee ballot on the State Board of Elections website.

What College Students Need to Know to Vote

If you registered to vote where you attended college and have since returned home, you may use the State Board of Elections website to:

- 1. Update your voting address to your home OR
- 2. Request an absentee ballot.

Any changes to your information must be made by the close of registration on May 27.

If you had already applied for an absentee ballot to be mailed to your college address, contact your local Board of Elections to ask how to cancel your absentee ballot application. If you are unable to change your absentee ballot delivery, you may be able to vote a provisional ballot on June 2 at a voting center in the county where you are registered.

If you do not make these changes, your ballot will be mailed to your college address and may not be forwarded – you risk losing your right to vote.

Voters with Disabilities

Each voting center will have ballot marking devices for use by any voter who would have difficulty reading and marking a paper ballot. Maryland also offers the option of internet delivery of a ballot, with an online ballot marking tool that is compatible with adaptive technology to enable those with disabilities to access the internet. To request internet delivery of your ballot, apply for an absentee ballot on the State Board of Elections website, but you will need access to a printer and postage to use this option as the ballot cannot be returned via the internet.

How Advocates Can Help Voters in Jail or Prison

While a person convicted of a felony cannot vote while they are in prison (but are eligible to vote upon release), persons in jail or prison for a misdemeanor or who are waiting for their trial can still register and vote

We recommend that the voter use their permanent address as their voting address, and then request an absentee ballot to be sent to the correctional facility. If they do not request the absentee ballot, the voteby-mail ballot for this election will be sent to their permanent address and need to be brought to the voter at the correctional facility. Visitation at correctional facilities may be limited due to the coronavirus, however. So, advocates will need to work with correctional supervisors to provide an inmate with a voter registration application when needed and an application for an absentee ballot from the State Board of **Elections website.**

FEDERAL OFFICES

U.S. PRESIDENT

Duties: The President is the head of state of the United States of America and is the Chief Executive Officer and the Commander in Chief of all military forces. The powers of the President are described in the Constitution and federal law. Subject to Senate approval, the President appoints the members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court Justices and federal judges. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to the United States Congress.

Base Salary: \$400,000 per year Term: Four years. Limit of two terms.

Criteria for Participation in VOTE411.org: All presidential candidates who will appear on Maryland's ballot are listed below. The League of Women Voters of the United States, through the League of Women Voters Education Fund (LWVEF), established criteria to determine which candidates to invite to respond to questions for the Voters' Guide.

Candidates qualified for invitations from LWVEF to provide responses to specific questions if they met the following criteria: • The candidate must have made a public

announcement of her/his intention to run for President.

• The candidate must have met the Presidential Election Campaign Fund Act's minimum contribution threshold requirements for qualifying for matching funds, based on the most recent data publicly available on the Federal Election Commission's website.

Candidates meeting these criteria after the print deadline for this Voters' Guide will be invited to participate. Their responses will appear online at VOTE411.org.

In addition, please note that voters cast a ballot for candidates in only one party during the Presidential primary season. LWVEF is required to have at least two candidates for President from the same party meet the above criteria before launching a Voters' Guide covering that party. At this time, only one candidate running for the Republican Party's nomination for President has met the LWVEF criteria listed above. Therefore, no Republican presidential candidates have yet been invited to participate. As soon as any two Republican candidates meet the criteria or the party's national nominating convention occurs, LWVEF will invite the qualified candidate(s).

Questions asked of all candidates for U.S. President who met Ground Rules:

ELECTIONS AND VOTING: What policies do you support to improve and secure elections and voting in our country?

COMMON GROUND: Please explain where you see opportunities for Democrats and Republicans to find common ground on the very serious issues facing our country.

IMMIGRATION: What, if any, steps will take to reform current immigration policies?

GUN VIOLENCE: Please explain the policies, if any, you support to address gun violence in America.

CLIMATE CHANGE: What, if any, actions would you work towards in your first 100 days to address the threats facing the US due to climate change?



U.S. REPRESENTATIVE

Duties: Representatives make laws along with the members of the Senate, and may conduct investigations on issues of national importance. Laws that impose taxes always begin in the House of Representatives. Representatives determine whether a public official should be tried, if accused of a crime.

How Elected: Each of the 435 Representatives is elected to a two-year term, serving a specific district. Each State has at least one Representative, but the total number is based on the population in the most recent census. Representatives must be at least 25 years old, have been citizens of the United States for at least 7 years and be residents of the state they want to represent.

Term: Two years Base Salary: \$174.000

GOALS: This is a critical election year. I believe our nation is at a crossroads. The agenda is often driven by monied interests (e.g. the Chesapeake Bay Foundation), which constantly fundraise while doing little to solve the problem.

GUN SAFETY: Laws restricting legal gun use facilitate crime because they prevent selfdefense by law-abiding Americans. Shootings in "gun-free zones" prove it. This is also true in inner cities, where legal self-defense is almost impossible. Crime has declined overnight in iurisdictions where it is allowed. Current laws against illegal guns are not enforced. Why add new ones? Enforce current law!

ECONOMY: This question illustrates a widespread but profound ignorance of economics. It assumes that anytime there is an income gap, someone else is gaining at our expense. Utterly FALSE. If someone else is gaining, it's because they have become more productive, which benefits all while hurting no one. Should an income gap matter to you if your economic circumstances are improving? Growth policy helps all.

GOALS: Americans are tired of politicians, tired of partisan politics and tired of inaction. Washington dysfunction is worse today under 18 year career politician leadership. As an Army Veteran I understand how to accomplish the mission for Americans irregardless of political affiliation. IMMIGRATION: The President has focused resources and money on treating the side effects of failed foreign policy instead of addressing the root cause of why people are fleeing Northern Triangle Central American countries for the United States. Trump's 2020 proposed budget slashes EPA funding by 31% to \$6B. I would increase funding from \$8B to \$10B and restore environmental enforcement at the federal level, because pollution knows no state borders.

GUN SAFETY: Americans own 17 million assault rifles, so banning these weapons won't have an impact. Homicides with rifles is 3% and handguns 65%. Criminals with handguns is the problem. We must plug the loopholes for the legal sale of unregistered 80% complete ghost guns kits. Laws must require the secure storage of guns to prevent theft. Gun violence criminals must be taken off the street and locked up.

ECONOMY: The Trump tax cuts have added to the gap by giving more money to large corporations and billionaires while hurting middle class Americans. I will push to repeal the cuts and update the tax code to tax corporations and billionaires at a fair rate. We must provide more money for small business startups and skilled labor training. Fixing our public schools will lay the foundation for this prosperity.

ENVIRONMENT: Since the U.S. is one of the world's leading polluters, the federal government must take the lead in addressing environmental concerns like climate change. We must re-join the Paris Treaty and work toward carbon neutrality. As an Appropriator, I support full funding for programs such as the Chesapeake Bay Program, which benefits our economy, creates jobs and preserves our natural heritage.

GUN SAFETY: I support banning assault weapons and high capacity magazines, background checks for gun and ammo purchases, no-fly-no-buy and tougher penalties for straw purchases. People convicted of certain hate crimes, as well as domestic abusers, should not be allowed to buy guns. TITLE 1: No, not until we measure what we're doing now, analyze the data, and determine if the current Title 1 allocation model is working. We need to identify the supports/programs that best serve our students and determine which Title I funding model would reinforce them. We should conduct a thorough review of what we do now and made decisions based on data, not on anecdotal information.

OPPORTUNITY GAP: If a school is closing that gap, we should look at what best practices might be applied at other schools. We must also focus on each child's individual achievement gap and apply appropriate supports - one size does not fit all. Reading is a foundation of learning and without the ability to read the gap will continue to widen, so all students must be able to read at/above their grade level.

TEACHING FORCE: Recruitment is just the first step, we also need to develop and retain our teachers of color. We must look nationally at how other districts recruit/develop/retain teachers of color, collect and review HCPSS data to see where improvements are needed, and implement a process that includes measures so we can monitor success.

MENTAL HEALTH: HPCSS must continue to work and partner with public and private organizations who have expertise in providing mental health services, but do so in a way that protects the privacy of the students and their families. If we are going to fund additional

mental health services additional funding will be needed.

SPECIAL EDUCATION: I'll work to fully fund Special Education and ensure we have highly qualified, appropriately trained teachers working with students with disabilities. We've increased the number of support staff instead of qualified teachers, and this ratio needs to be adjusted. We need a compliance position to check IEPs and identify areas for additional staff training to ensure IEP requirements are

SECURITY: We need to address bullying consistently across our schools. There are too many parents and students not being told there is a formal process for reporting bullying. We need to be vigilant in training schoolbased staff on bullying procedures and how to appropriately interact with both the victim and the alleged bully, and their families.

BUDGET: As an incumbent, and Operating Budget Review Committee member for 3 years before being elected to the BOE, I have a very good understanding of the budget. We must institute responsible budgeting and spending of tax dollars that takes into account current and future needs, and link funding decisions to data-driven student outcomes.

I will require school safety practices to include mental health impacts on students and staff as a major aspect in all strategic planning.

SPECIAL EDUCATION: I will support the identification and removal of systemic barriers to the identification of students in need of special education support. Families of students should not have to bear the financial burden of retaining counsel for the purpose of getting their students' needs recognized. I will support a review of the efficacy of special education support programs so that trouble spots can be fixed.

SECURITY: I will support a review of school discipline policies to ensure students are safe from disproportionate policing which involves the criminal justice system into situations that should be handled through proportionate education based conflict remediation. Students should not be exposed to firearms unrelated to educational pursuits.

TITLE 1: Current fiscal realities require reexamining how all of our money is being allocated, but the current system does have merit. Targeting funds at the ES level allows for the earliest and most effective interventions to generate positive learning outcomes. Another consideration in any shift from schoolwide to targeted assistance would require increased overhead funding for required reporting. **OPPORTUNITY GAP:** We have to make a real commitment to closing the gaps within our system. Unfortunately, the data is clear that we are not doing enough. Addressing concentrations of poverty and socioeconomic segregation are a step in the right direction, but it takes resources too. Differentiated pay to incentivize retention of quality educators in high need schools and early intervention programs are examples.

TEACHING FORCE: Diversifying our teaching force is vital to addressing the achievement gap and increasing the vital sense of belonging for our students of color. Programs such as Teach for Tomorrow should be expanded into surrounding MSI/sHBCUs and we should be following other best practices such as including current teachers of color in the hiring process, teacher residencies and adjusting our hiring timeline.

MENTAL HEALTH: Funding is currently allocated to make up for the deficiencies in mental health supports currently offered. Some resources would not be needed if students had more access to mental health services instead. In the absence of funding, there may be opportunities for further grant funding or private development for the system to receive subsidized community services through partnerships.

SPECIAL EDUCATION: As a special education parent, I am committed to supporting our special educators and students. Children thrive through relationships and stability, yet we are critically understaffed and burnout associated to previous cuts is costing us quality educators who are choosing to leave the system. Families should also be connected with help adjusting to diagnoses, developing IEPs and advocacy tools. SECURITY: School security measures should be proactive and collaborative whenever possible. Spending has leaned towards security response over prevention and mitigation. We need more intentional restorative justice practices, access to mental health services, bullying prevention, substance abuse education and to continually include students in these discussions to foster a safe school community. **BUDGET:** I have not worked with budgets on the scale of HCPSS, but I have worked with significant budgets in my time at the University of Maryland. I manage the wages of over 100 employees in addition to operating and capital budget planning. I am adept at identifying redundancies, seeking to maximize value on money spent, exploring new revenue sources and thinking outside the box for solutions.

Early intervention services can have a significant impact on educational outcomes and can increase long-term success. However, the funding is used for school-wide programming which can miss some of our neediest students. HCPSS should also use intensive one-on-one instruction to improve

OPPORTUNITY GAP: Students from traditionally disadvantaged backgrounds have significantly fewer educational opportunities compared to their peers. This gap starts even before kindergarten. Children without access to early education may enter school up to two academic years behind their peers and may never catch up. I will work to expand the number of high quality and affordable pre-K programs in our schools.

TEACHING FORCE: Teacher diversity can greatly improve ALL students' outcomes through relationship building and cultural connections. We must actively recruit from teacher education programs with large populations of teachers of color like Historically Black Colleges and Universities. Then, to retain these teachers, we must also make the workplace welcoming through equity and implicit bias training.

MENTAL HEALTH: To improve access to

services, it is necessary to increase the number of mental health professionals in each school. Also, it is important to expand training for everyone surrounding our young people to recognize warning signs and provide timely help. Early intervention is the best prevention. We also need to work to create inclusive and safe school climates and to build strong relationships.

SPECIAL EDUCATION: Some parents feel overwhelmed and intimidated by the complex special education process creating a distrust in the system. This can be mitigated by developing knowledge-based guidelines to make the process more transparent and universally consistent. Special educators are stretched thin. Increasing the number of paraeducators alleviates some of their workload and allows more focus on students.

SECURITY: Any additional security measures should be proactive and should not interfere with the learning environment. This includes increasing access to mental health professionals, creating a positive school climate, and using restorative practices to foster positive relationships. A balance between physical safety and psychological health is important.

BUDGET: As an engineer, I managed the budget of several multimillion dollar vehicle programs. I serve on the Howard County Library Board of Trustees which requires understanding of a large budget and its impact on the fidelity of the system. I will focus on waste reduction and expanding partnerships with other county services. It is imperative that we prioritize services that directly impact our children.

OPPORTUNITY GAP: I'd work with County legislatures to identify initiatives for closing the gap. The gap begins long before school starts and only widens. I'd leverage my expertise and experience in innovation to design a solution that meets the needs of those underperforming. This means, we'd spend time researching (e.g. interviewing, observing, etc) the specific unmet needs and how we could design solutions.

TEACHING FORCE: I'm a fan of Malcolm Gladwell and he wrote about unconscious bias when he discussed how women were disproportionately shut out from Orchestra openings. When they began doing blind auditions, the number of women accepted rose dramatically. I think

MENTAL HEALTH: Previously I taught Resilience for the US Army - teaching Army soldiers the cognitive tools of resilience. The idea was that we could inoculate them against the psychological ills of war and the military. This equipped them with the skills to bounce back and push through the inevitable adversities they would face. Similarly, I would propose teaching students the cognitive tools of resilience..

SPECIAL EDUCATION: I have a son who has ADHD and appreciate the hard work that special educators do in our schools. A big challenge I've encountered and heard from others, has been compliance with special education supports. A big part of that is that teachers don't have the time/resources to feel like they can comply. I would work to increase personnel support while decreasing non effective tasks (eg. overcasting)

SECURITY: I've never thought HoCo schools needed more security. In my experience they have done well in this regard.

BUDGET: I've managed and led multi-million dollar programs while working with clients like the US Navy, Army, etc. I always kept my budget on time, on budget, and within scope. I'm very good at this. One thing I would do is work with teachers to identify what is NOT working. I have no shortage of stories of teachers telling me about things that are a complete waste of time and money. Those are easy wins.

TITLE 1: I would like to see schools above 60% FARMs, supported by a potential increase in the distribution of Title 1 funding. There should also be consideration in this analysis for the percentage of English Language Learners, students receiving special education services, and actual class sizes. I believe a closer look at the Title 1 allocations can contribute to closing significant opportunity gaps.

opportunity GAP: I prefer a holistic approach that focuses on making students, educators and families feel welcome and valued, quality instruction from the beginning and a reduction of chronic absenteeism. I plan on supporting HCPSS with incorporating more inclusion work, updated anti-bias work for whole school populations, resources to incorporate diverse curriculum and materials, and restorative justice practice

TEACHING FORCE: I applaud the efforts taken to recruit teachers of color. Steps must also be taken to support and retain these educators. Expanding updated anti-bias work to encourage an inclusive environment will help us keep these valuable assets to our schools. Additionally, we need to ensure diverse materials are integrated into the libraries, text books and literature used in the curriculum and classroom.

MENTAL HEALTH: I would like to see more efforts made supporting and educating students not only self-care but also where safe places are to reach out for help. Feedback I hear from students is that they sometimes have questions and want to explore options but are unsure what is available. Classroom, current event discussions, school announcements and assemblies are great places to discuss mental health topics.

SPECIAL EDUCATION: The diverse needs of students demand that the school system adequately and transparently invest in a fully trained workforce. Early intervention, clearly-defined goals, workable caseloads, and communication should be emphasized so children can perform to their fullest potential, minimizing academic slides. We need to ensure HCPSS opportunities allow all abilities to be included and supported.

SECURITY: Students and staff should feel safe without being inhibited by extra security controls that create tension and interfere with a safe learning environment. I've learned that outside school hours custodial staff support security, giving them less time to complete their assigned duties. The schools have both SROs and SAs. These resources could be staggered to fill the after-hours security gap.

BUDGET: Working on the OBRC, I recommended PMs identify program areas that can withstand trimming and those that are on the cusp of not being able to maintain their vitality. The current budget deficits are impacting programs, increasing class size and depleting the general fund balance. Funding formulas should include HCPSS student enrollment as well as non HCPSS students utilizing transportation service.

TITLE 1: Elementary investments are foundational, so I support the majority of Title I funding going to the highest-need elementary schools first. In visiting middle schools, I recognize the significant unmet needs our 6th-8th grade students are facing at a critical point in their development. Principals and administrators have the best insight into the usage of Title I funds in their buildings.

OPPORTUNITY GAP: Using multiple strategies to address disparate opportunities for students of color and in low-income homes must include continued investment in programs like Black Student Achievement and Community Liaisons that increase engagement. We need to encourage diverse participation in GT/Honors/Ap Coursework. We also need to invest in a culturally-informed workforce that mirrors the students we serve.

TEACHING FORCE: Enhancing workforce diversity benefits ALL students. Affinity groups for staff should be expanded to provide a safe forum, with regular feedback to senior leadership, for sharing experiences, mentoring, and obtaining ideas to further increase diversification. Expansion of partnerships with educational programs at HBCUs and minority recruiting events should continue.

MENTAL HEALTH: Student & staff mental health & well-being stand out as major issues confronting our system. Suicides, bullying, drug use, and other risky behaviors have increased, impacting everyone. I support partnerships with groups like the Horizon Foundation & the County Health Dept to increase the number of social workers & mental health providers within our schools to assist our students.

SPECIAL EDUCATION: Improving the quality and availability of special education services is a high priority and long overdue. Our staff have the skills to evaluate children for special education eligibility, but responsibilities and

caseloads are overwhelming without adequate time to assess, manage, and instruct with fidelity. Retention must also be prioritized to prevent burnout and attrition.

SECURITY: Ensuring the safety and security of children is critical. Evidence-based approaches must be applied to create safer schools. In addition to creating a culture that supports student mental health and relationship-building, a clear plan must exist for reporting concerns, assessing threat risk, and responding using established emergency protocols including a mental health crisis component.

BUDGET: I am a CPA (not practicing currently) with financial and IT experience in large & small companies. This is my 4th budget cycle with HCPSS analyzing a very complex budget and asking informed questions. Educators and classroom supports are my top budget priority. All new positions should have the question asked: does this position support educators in our core mission?

TITLE 1: I would change Title 1 funding so that it no longer operates as a Schoolwide program at elementary Title 1 schools and is specifically directed to the neediest students. This more directed use of funds would better support the needs of those students instead of benefiting children with lesser needs.

OPPORTUNITY GAP: To close the gap, we need to look at each individual school and identify the unique needs of the students at that school. Once we know the needs, we can put into action directed measures that will specifically support those students. Our students are unique and therefore we need to stop using one-size-fits-all approaches and tailor support to the need.

TEACHING FORCE: The county needs to significantly improve its overall hiring process to attract the best and brightest teachers of all backgrounds. Howard County is very late to offer jobs compared to neighboring jurisdictions that are fighting for the same talent. Recent college graduates frequently have loans to pay and accept the first job offer so that they know they have a position and we lose out.

MENTAL HEALTH: We need to work with our community organizations to ensure that students have access to the mental health services that they need. This could include facilitating communication regarding the availability of services. Our teachers know the students best and can also act as the first line of support with referrals to outside programs.

SPECIAL EDUCATION: Our special educators need additional funding so that we are able to meet our legal obligations to these students. We need to work to identify learning disabilities as early as possible and then implement research and science-based proven strategies that will enable these children to achieve to their fullest potential.

SECURITY: We need to begin with making sure that our schools are within the targeted capacity limit. Some of our facilities are older with more narrow hallways. School overcrowding makes this situation very unsafe with large numbers of students trying to move around at the same time. As we plan new schools, we should consider and evaluate new security technology.

BUDGET: I have worked in business for over the last 15 years and have experience working with both large and small budgets, including capital and operating budgets. I will approach budgeting by identifying where our money is spent and evaluating the effectiveness of our programs. We need to ensure that taxpayer money is being spent in prudent way that best supports our students.

TITLE 1: We need to be more intentional with differentiated staffing, including Title I. HCPSS should allocate additional staff at all Title I schools and schools with high socio-economic need. Using Title I funds (only 0.5% of the

budget) at the elementary level is critical-early intervention has the great, long-term impact on students. Changing would disadvantage our neediest students even more.

OPPORTUNITY GAP: To close gaps, budget priorities must staff positions that can have the biggest impact. Successful programs like reading and math support teachers, Black, Hispanic, and International Achievement Liaisons, Diversity, Equity, and Inclusion positions have not kept pace with enrollment growth. We must develop budgetary formulas to increase these positions annually to support students.

TEACHING FORCE: Student teachers and recruitment should come from more HBCUs, like Howard, Hampton, and UDC. We need to hire administrators of color and retain current educators of color. If we cannot keep those we recruit, then diversification will be an endless cycle of insufficiency. Newly hired educators need great mentoring, professional development, and affinity/support groups of similar teachers.

MENTAL HEALTH: Continue and grow partnerships with organizations that provide grants, services, and supports for our students experiencing emotional crises. We need to seek additional funding to pay for more school based mental health experts; teach social-emotional learning to students to potentially short-circuit later problems; and provide robust education in digital citizenship to prevent cyber-bullying. **SPECIAL EDUCATION:** We need to increase special education staff. Current educators are overburdened. Absent steady, consistent, significant growth of staff, we cannot continue the current model nor improve service. Special education families already face difficult challenges, HCPSS should not be the source of more. With increased staffing, we can relieve strain, reduce caseloads, and better meet service needs.

SECURITY: Every school needs to have secure vestibules where entry is controlled, a working LobbyGuard™ system to check and keep track of visitors and check sex-offender registries. School Resource Officers in schools need continuing education to develop skills to build community, to practice restorative justice, and not be involved in discipline (which can increase the school to prison pipeline).

BUDGET: As a current Board member, I am experienced in making tough decisions for the nearly billion-dollar school system budget, using my degree in economics and my training in data analytics to make smart, prioritized choices. I collaborate and communicate well with our funding authorities and participated in developing a plan to eliminate the deficit. I offer solutions rather than just vote no.

TITLE 1: I would revisit Title I funding allocation, and recommend considering a shift from a school-wide model to a targeted approach that better supports disadvantaged students. Also, Title I funds are currently used for a range of activities, including general training. I would advocate using funds only for targeted activities that correspond to better educational outcomes for disadvantaged students.

opportunity GAP: I would begin by spending Title I funds on the most disadvantaged students to provide these students with the appropriate support, including tutoring and supplemental instruction. I would also advocate for early screening for health/social services, providing education opportunities to parents and consider creating magnet programs in

schools serving high concentrations of low income students.

TEACHING FORCE: Minority teachers comprise 27% of the workforce, yet the percentage of minorities in the community is 44%. To close that gap, I would engage more minorities in the recruiting process and better target recruiting efforts to improve the pipeline of minority applicants. Hiring minority leaders, including principals and central office staff, is also critical to improving workforce diversity. **MENTAL HEALTH:** To address the mental health crisis facing our students, I would focus on training for all educators to recognize and appropriately respond to the warning signs of mental health concerns. We must provide educators and staff with the proper resources to focus on student well-being. Emphasizing testing and measures that focus on school performance should not be the sole focus of our educators

SPECIAL EDUCATION: There are two critical aspects of special education challenges that I would address. First is proper training for educators and support staff who interact with our special education students. While we need to increase the total number of special educators, we must ensure they are properly trained (OG). Second, I would focus on regular assessments of performance and make adjustments as needed.

SECURITY: The security challenges in our schools are twofold: physical security of buildings and the mental health of our children. While some measures have been taken to address physical security, at the core of many challenges are the mental health issues that plague our children. We must better address depression, anxiety and bullying behavior across our schools to prevent these crises from occurring.

BUDGET: I have executive leadership responsibility in a >\$1.5B organization and extensive experience successfully leading organizations while balancing limited resources. I would take a more rigorous approach to decision-making that would use data, community input, and objective analysis to prioritize the most critical needs associated with educational outcomes and identify the most responsible solutions.

TITLE 1: Title 1 is a critical part of how Howard helps low-income children succeed. While Title 1 can have an increased impact by focusing funding on individual schools, we need to make sure that spending meets the needs of students throughout the county. We need to reassess the use of Title 1 funds in light of the recent redistricting to ensure we meet the needs of our students.

OPPORTUNITY GAP: We need to leverage development dollars for academic programs as well as roads and sidewalks. By investing these funds in social, not just physical, infrastructure we can develop programs that offer all our students the opportunities and networks that wealthier families take for granted. We have a wealth of skilled employers in the county who can be a resource for our schools if we so choose.

TEACHING FORCE: Located within driving distance of two major cities, Howard County needs to establish stronger connections with the diversity that already exists in our region. There is a wealth of universities and colleges – including several HBCUs – with strong minority student organizations for the county to connect with, which can help us to attract and recruit a workforce that reflects our own diversity

MENTAL HEALTH: When it comes to mental health, teachers are our true first responders. Teachers need to have time to connect with their students and ensuring access to resources like paraeducators gives them the time and flexibility to connect with students at a more personal level. In combination with in-school mental health specialists, we can support early identification of mental health issues.

SPECIAL EDUCATION: Special education in our county is at a crossroads. Our current "Wait to Fail" model has itself failed and we can no longer look the other way. Parents need

access to resources which can support the development of robust IEPs, not just a quick 504. Early and active intervention allows kids the opportunity to thrive and succeed, including our doubly exceptional students, dovetailing with GT goals.

SECURITY: School security starts in the community. Teachers already have training and run regular drills for specific scenarios, but prevention is the best defense. Building strong connections between neighborhoods, local schools, and the HCPD allows problems to be addressed without invasive solutions like metal detectors or arming teachers.

BUDGET: As the former Chief Financial Officer of HydroLogics, Inc., I know my way around a budget. The most important part of managing spending is a clear understanding of what works and what doesn't. We need clear performance metrics that identify success so we can direct dollars to programs that work and refine those in trouble. This sets guideposts for good financial management beyond a single cycle.

TITLE 1: Yes. HCPSS allocates the funds to 13 Title I elementary schools to operate school wide programs. The disadvantaged students in non Title I schools will not benefit from the program. I propose to continue using a large part of the Title I funding to school wide programs and start a pilot program to apply a small part of the funding to improve high school dropout rates for disadvantaged students.

OPPORTUNITY GAP: Addressing the root cause of opportunity gap involves efforts outside of school system. The schools need to foster a positive learning environment, take time to understand the students, help them gain confidence, motivate them to learn, and adopt teaching methods that sufficiently address student need. The schools can provide free tutoring services to disadvantaged students and help them improve.

TEACHING FORCE: Since there are only a limited number of teachers of color in the potential teaching force pool, we need to encourage more colored students to become teachers. To inspire students of color, we can help them identify role models that they could relate to other than race, such as a teacher who came from poverty, a teacher who is a non-native speaker, a teacher who overcame obstacles.

MENTAL HEALTH: In public health, education, early detection, early intervention are effective strategies. It is essential for school system to raise mental health awareness among students, parents, teachers, and communities, and provide trainings so people know how to appropriately react. The Schools need to work on changing the overall environment so students can feel comfortable talking about mental health.

SPECIAL EDUCATION: We need to advocate for more local, state and federal funding for special education and more training for special educators. The Schools need to raise special education awareness among parents, teachers, so they can detect symptoms early. Early detection and early intervention can help special education students improve significantly and relief the work load of special educators in the long run.

SECURITY: Fostering a welcoming and safe environment helps improve security since a good environment brings the best out of each other. The schools need to provide security trainings, provide preparedness procedures, establish reporting and monitoring system to detect security threats early, and act accordingly. Schools can adopt security system to conduct quick background check on visitors. **BUDGET:** I have been a Federal Acquisition Certified Contracting Officer's Representative

MENTAL HEALTH: As a board member, I will seek out experts in mental health and social work to discover strategies for improving mental health across our entire student body. I would also promote increased trauma-informed staff training, suggest a county-specific socialemotional curriculum, and push for an open communications process for discussing the current issues of mental health in our schools. SPECIAL EDUCATION: The first step would be restoring the special education staffing cuts to ensure that we have adequate staff for all the children needs. We need to ensure we are not only looking for additional staff continuously, but we offer the resources and training needed for the current staff to meet the diverse needs of our students along with exploring partnership options with healthcare organizations.

TITLE 1: Identifying at-risk children involves a targeted approach. Title I funds are being used to offset costs for an entire school, regardless of a child's individual need. Some children receive resources not intended for them and for which they do not benefit. Conversely, some

qualifying students are denied supports because they do not attend a designated Title I school. Targeted allocation is the key.

OPPORTUNITY GAP: HCPSS should not be used as a proxy for failed municipal zoning and development oversight. Not everything in Howard County should be for sale, and the County Council must stop deflecting their responsibility. HCPSS can do its part to help close opportunity gaps for all children by providing all schools with the resources they need to ensure all children have the opportunity to achieve.

TEACHING FORCE: The workforce should reflect our community's values. It is naïve to assume because someone looks a certain way, they are better capable of relating to a student's needs. Talented and skilled educators are a hard commodity to find. Minimizing that value based on race is both short-sighted and insulting. Hiring highly qualified, talented, and compassionate educators serves the needs of all students.

MENTAL HEALTH: Having personally been impacted by child suicide, it has left me with a permanent soul-crushing scar. A multi-faceted school and community partnership for addressing student mental health will save lives and make our schools a safe place for everyone. Mental illness is multifactorial; however, the solution begins with a whole community approach and eliminating the stigma of mental illness.

SPECIAL EDUCATION: Early intervention using evidenced-based curriculum is the key to improving outcomes and decreasing the cost of special education. The earlier a student is identified and receives services from a highly qualified professional, the less likely it is for that child to need prolonged special education services. Families and students feel supported when they actually are supported; it's that simple.

SECURITY: It would be irresponsible to comment on specific security measures, existing or not. The overarching goal of school security involves hardening the target through preparedness. Addressing student and staff mental health is a good example of preparedness. Providing children and staff with brick and mortar schools instead of fiberglass trailers is another basic concept to prevent disaster. **BUDGET:** With nearly two decades of public administration experience, including as a BOE member in NJ, I understand what fiscal responsibility and budgetary oversight require. There are several ways to increase revenue without cutting or making our community pay more. Doing what we have always done no longer works. The BOE must focus on accountability across a wide array of school administrative issues.

TITLE 1: Many years ago the decision was made to concentrate the use of Title 1 funds in the elementary schools. The theory being that early intervention is the most effective. I continue to believe that is true. However, we have older students who have unmet needs. I would like to see HCPSS evaluate options for using some Title 1 funding for the benefit of eligible older students.

OPPORTUNITY GAP: Adequate staffing and small class sizes must be maintained for our most vulnerable students. I support providing elementary and middle schools that run on a 9week on/3 week off calendar that would be VOLUNTARY, with opportunities for enrichment, remediation, and mini camps offered at little or no cost during the 3 week off periods. This has proved very effective for the most vulnerable students.

TEACHING FORCE: The HCPSS MUST alter its hiring schedule and offer "open contracts" so active recruitment efforts (including at HBCUs) can lead to hiring great candidates before they commit to other systems. After hiring, however, HCPSS MUST provide mentoring, support, and professional development for all of our new teachers, but especially teachers of color who face additional obstacles.

MENTAL HEALTH: Starting with providing properly staffed and nurturing classrooms as a preventive measure for the anxiety, stress, and mental health issues that plague our children, we must provide training to the classroom educators to identify issues early, adequate counseling and psychologist services at school, and a robust referral operation for ongoing care including on site access to follow up care.

SPECIAL EDUCATION: Appropriate staffing levels of properly credentialed and trained educators and support staff, is critical to all students. None are currently receiving our promised level of service, but especially our special education students. Years of cuts to special education staff and programming have led to an untenable situation. Acknowledging this truth is the first step, with investment following.

SECURITY: The most effective security measure is properly staffed schools with well trained educators and staff with the time and resources to know their students, and see and respond to distressed students in a timely way; to intervene before crisis situations erupt. Taking money out of the classrooms to build up a system to respond to crisis caused by the lack of classroom resources has failed miserably. **BUDGET:** I have 8 years of first hand experience with the HCPSS budget, including seeing what has not worked. "Zero based" budgeting has not really occurred in the past, but should be implemented as a reset for the system. The budget should be rebuilt from the "bottom up"starting with the classrooms, educators in front of students, and the resources they need. All choices should begin with the classroom. g a welcoming and safe environment helps improve security since a good environment brings the best out of each other. The schools need to provide security trainings, provide preparedness procedures, establish reporting and monitoring system to detect security threats early, and act accordingly. Schools can adopt security system to conduct quick background check on visitors.

JUDICIAL OFFICES HOWARD COUNTY CIRCUIT COURT JUDGE

DUTIES: Judges preside in the Circuit Court, which is a trial court that hears major civil cases and more serious criminal cases, such as those requiring a jury trial. Circuit Courts also may decide appeals from the District Court and certain administrative agencies.

SALARY: \$174,433, effective July 1, 2021 **TERM:** Fifteen years, no term limit. Mandatory retirement age of 70 years.

HOW ELECTED: The state is divided into 8 Judicial Circuits. The General Assembly determines the number of judges in each circuit and county. When there is a vacancy, the Governor appoints a qualified person to fill the office. Each newly appointed Circuit Court judge then must stand for office at the first election that occurs at least one year after the vacancy happened. One or more other qualified members of the bar may also run to fill the vacancy. All candidates run on both the Democratic and Republican primary ballots.

The court must continually examine itself to determine whether it is making findings based on applicable laws and the merits of the case and not on any preconceived notions or personal preferences; and be willing to re-examine any previous rulings, if relevant information is timely discovered.

Maryland will send a total of 38 delegates to the Republican National Convention, which will be held August 24-27, 2020 in Charlotte, NC. Each of the Congressional Districts will elect 3 delegates and 3 alternates. The presidential contender receiving the greatest number of votes in each District will receive the votes of all three of that District's delegates. Each voter may vote for up to 3 candidates for delegate and 3 candidates for alternate.

In addition to the 24 delegates elected by the voters, 11 at-large delegates will be selected at the Maryland GOP convention by members of the State Republican Central Committees or their proxies. The votes of at-large delegates will be allocated to the presidential contender receiving the greatest number of votes in the primary statewide. Finally, three party leaders (the National Committeeman, the National Committeewoman, and the chairman of Maryland's Republican Party) will attend the convention and vote by virtue of their positions.

Maryland will send a total of 119 delegates and 8 alternates to the Democratic National Convention, which will be held July 13-16, 2020 in Milwaukee, WI. Congressional district-level delegates will be selected based on the proportion of the vote won by the presidential candidate to whom they are pledged. In addition to the 65 delegates from the Congressional Districts, there

will be 23 delegates who are automatic party leaders and elected officials (PLEO) based on the positions they hold. Finally, the Democratic State Central Committee will select 10 additional party leader (PLEO) delegates and 21 at-large delegates.
